Building

- On an Embassy Building in the Middle East, Richard was appointed by the Employer as a quantum expert. Richard produced an expert's report, supplementary report and 2 joint statements. Richard attended experts' meetings and the trial at the High Court in London. The dispute settled around two/three weeks into the trial prior to Richard giving evidence.
- On a residential complex in London, Richard was appointed by a local authority
 as a quantum expert. Richard produced an expert's report and supplementary
 report. He then gave expert testimony for around three days during the trial at
 the High Court in London.
- On a national sports stadium in London, Richard has been appointed on behalf

 joints. The dispute is ongoing.
- On a large property in Essex, Richard was appointed by the Employer as a
 quantum expert. Richard produced an expert's report and a number of joint

Director

- On a large wine distribution warehouse, Richard was appointed by the operator as the quantum expert on remedying extensive defects to piling and ground slabs. The dispute is ongoing.
- On a significant residential and retail complex in Sheffield, Richard was appointed by the Developer to review the final account and consider issues of measurement, pricing and loss and expense. Richard prepared a joint statement and an expert's report. The dispute settled favourably just before trial in the High Court in London.

Transportation

Richard prepared 2 joint statements with the Employer's expert, which required visiting the Joint Venture's accounts department and auditing the claimed costs. Arising from this exercise, the joint reports were presented during the Arbitration and the Arbitrator's Award was extremely favourable to the Joint Venture. As a result of this, Richard was retained by the Joint Venture as quantum expert on the remainder of the Channel Tunnel Rail Link, involving the valuation of substantial compensation events and disallowed costs.
- On a main vehicular tunnel running under the Thames, Richard was appointed by the Contractor to consider significant mechanical and electrical claims from a specialist sub-contractor. Richard prepared a joint statement and the dispute settled favourably.

- On a major rail upgrade project, Richard was appointed as quantum expert to advise on the final account. The dispute is ongoing.
- On a road project in Ireland, Richard was appointed by insurers on behalf of the Consultant Engineer to provide independent opinion on variations and claims. The dispute is ongoing.

Process

 Richard was appointed as a quantum expert by the owner of a large process installation in the North of England. Richard prepared 3 joint statements, two expert's reports and gave evidence in the High Court. The trial judge was complimentary in his judgement (BAILII 2013 EWHC 2916 TCC - Paragraphs 393 to 395, 402, 441 to 450, 486 to 495 and 499 to 507).

Marine

- On a defective quay in the North of England, Richard was appointed by insurers
 on behalf of the Engineer in a negligence claim. Richard, in consultation with the
 geotechnical and dredging experts, produced a quantum report on various
 engineering solutions to stabilise and rectify the defects. Following meetings
 with the Employer's expert, favourable joint statements were prepared and the
 matter settled only days into the trial.
- On a floating pontoon to receive ocean liners, Richard was appointed by insurers
 on behalf of the Engineer in a negligence claim. Richard, in consultation with the
 engineering experts, produced several quantum reports on issues associated
 with steelwork, reinforcement and concrete. The final quantum report was used
 in a mediation which resulted in an extremely favourable settlement.

Agricultural

 On an epidemic in East England involving a highly contagious disease associated with pigs, Richard was appointed by a government department to provide expert opinion on discrete issues of custom and practice in the construction industry. Richard gave evidence at the High Court in London and the trial judge was complimentary in his judgement (BAILII 2006 EWHC 3426 TCC – Paragraphs 223 and 225).

Richard has been involved in around 200 no. adjudications in the following capacities:-

Richard is an experienced adjudicator who has been on the RICS panel for over 15 years and the TeCSA panel for almost the same period. The following disputes provide the variety of disputes that Richard has dealt with.

Building

- On a Central London auction house involving disputes with the stone floor to the reception and adjoining galleries.
- On a Central London office block involving a dispute with defects to a substantial installation of glazed partitions.
